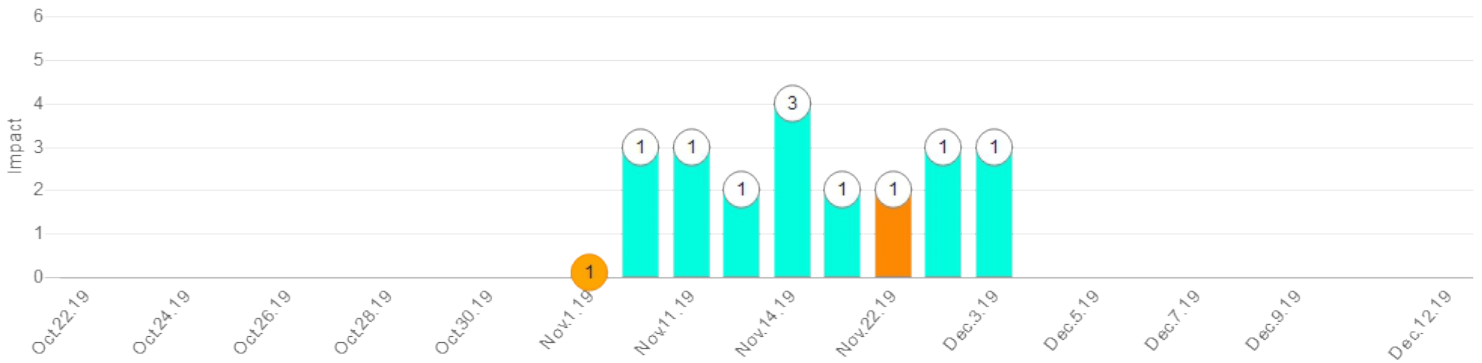

It is a post about me and going through several of the complaints I'd been told about and a couple more I knew nothing about. It's vile. I'm being called a racist bigot and 'alt right' It says I'm going to lose my job. My wife is in a terrible state. She rang her friend about the post and asked for more information. Her friend has asked her to keep away from her and subsequently blocked her Facebook access.

During the lunch break I went to a local cafe and met with a colleague David Miller who'd texted me during the day. He's known me for 15 years and has worked in my dept for the past 5years. He heads one of my teams. He told me what he knew about the complaints. There's a member of staff Jessica Smith who joined the company in January of this year. She works in the accounts dept and David said she's "some sort of social justice warrior". She's winding up the younger and more junior members of staff and encouraging them to complain. Some staff seem frightened of her and she can be very aggressive if anyone says anything remotely right wing. She's a remain fanatic and calls anyone who voted for Brexit a "moron" David told me "Watch your back. She's after your scalp"

I had an email first thing this morning from my manager to say the timetable they'd set for moving forward with my complaints had been extended for another two weeks as there had been another 4 complaints about me. It's always about something I'm alleged to have said which they find offensive for one reason or another. Looks like this is going to drag on for ages and it's having an effect on my health. It's making me anxious and I can't sleep.

I went to see my GP today as I'd been feeling really low. The pressure is mounting as my wife is ill because she thinks I'm going to lose my job. She's been off work this week and has been prescribed anti depressants. The children are a worry too because they've been hearing things at school about me. My son is being bullied about it and got into a fight defending me. My daughter asked me what a transphobic is when I got back from work yesterday. A child had said that about me when my daughter was in the playground. It's upsetting us all. My GP said I should take some time off and offered me anti depressants but I think I need to be at work to see what's happening.
